### Supplemental Savings Plans

The Arizona State Retirement System advocates for additional retirement savings to supplement members' ASRS benefits in retirement. Partnering with Nationwide Retirement Solutions, the ASRS oversees a selection of supplemental savings plans that employers can participate in and offer to their employees.

Meet with one of our Nationwide representatives to ask questions about the plans you participate in or learn more about these opportunities.

### Compensation & Contribution Reporting

Contribution reporting is an important responsibility, and knowing what is and isn't reportable compensation can be confusing. Meet with subject matter experts to answer your questions about what is includable as compensation and what pay type code best fits when completing your contribution summary reports.

This session will also include important reminders about corrections or adjustments, maximum compensation limits and what to do if you get a notice of credit or late charge.

### Long Term Disability (LTD)

Broadspire Account Executive Barry O'Dowd is back to provide updates and reminders on the Long Term Disability plan.

If you are an LTD Associate or Signer for your organization, this breakout session is for you.

### Health Insurance Premium Benefit Program

For employers who provide a COBRA or retiree health insurance plan for your retired employees or employees on LTD, this breakout session will provide timely updates from subject matter experts on any process changes, who is eligible the premium benefit and how to remain in compliance.

For state agencies & universities, this session will go over how the HIPB is calculated and applied to those who enroll in ASRS and/or ADOA health insurance or who may be dual retirees with other state retirement systems.
