STEP 1

Complete the authorization form in its entirety using dark ink.

STEP 2

Make two copies of the completed authorization form. Return the original contract to the ASRS at least three full calendar months prior to your termination. Forward one copy to your employer and keep the other copy for your records.

Restrictions

- Termination pay may only consist of pre-tax vacation, sick, and overtime pay submitted by your employer.
- Your employer must pay your pre-tax termination pay directly to the ASRS promptly upon your termination.
- You must continue working at least three full calendar months after you submit this form to the ASRS (a full calendar month equals the first through the last day of a month).
- Your cost invoice must be issued at least three full calendar months before but no more than six months
 prior to the date you terminate employment.
- The election is irrevocable and binding.
- Your termination pay must be received and processed before the ASRS will accept any other form of payments (rollovers or after-tax lump sums).
- If you terminate employment and immediately retire, your retirement processing may be delayed.

Completing the Termination Payment Authorization for the Purchase of Service Credit form

SECTION 1 – Member Information

Print your personal data.

SECTION 2 – Termination Pay Information

- Enter the Request ID number from your invoice. You will need a separate *Termination Payment Authorization for the Purchase of Service Credit* form for each Request ID number.
- Enter the name of the employer that owes you termination pay.
- Check one of the boxes to indicate your election.
 - If you elect "All Termination Pay," and your termination pay is more than the cost of your eligible service, the balance will be sent back to your employer. Your employer will then be responsible for paying that amount to you.
 - If you elect a specific dollar amount, the ASRS will accept up to that dollar amount to pay for eligible service. If your termination pay is less than the specified dollar amount, the total of your termination pay will need to be submitted.

SECTION 3 - Certification, Understanding, and Signature

- Carefully read each Member Statement of Understanding.
- Sign and date the form. Your signature confirms your understanding and agreement to the terms of the contract.
